Mastropiétro Winery Wedding & Receptions Packet

Thank you for considering Mastropiétro Winery to host your private event! A party, meeting, or casual get-together at our winery is special, unique, and fun!

The following information describes our services, charges, and general information for weddings & receptions. If you need more information or are ready to book your event you can reach us at 330-547-2151. A signed license agreement and rental payment in full will secure your reservation.

Wedding Ceremony (Only) Package:

Reservation Fee: \$500.00 for a wedding ceremony. Payment for the Wedding Ceremony must be made in full at the time the reservation is made.

Available Times: Afternoon weddings may be scheduled at 12 Noon or at 3:00 PM at the Arbor.

The Wedding Ceremony Package includes a Wedding Ceremony at the Arbor with (75) chairs for a maximum of 75 guests and use of the Gazebo.

Guests may gather at the Arbor and at the Gazebo area before and/or after the Ceremony. The Gazebo is available for a 2-hour window for guests during the wedding. There is seating for a maximum of 48 people on the Gazebo. A \$1.00 fee per chair will be charged to the Licensee if additional chairs are moved to the gazebo. Seating is not available in the Tasting Room or on the Main Patio area for guests.

The Gazebo must be vacated by 2:30 PM for an early wedding (12 Noon) and by 5:30 PM for a later wedding (3:00 PM). Additional chairs will not be added to the Gazebo.

The Banquet Room is available 1hr prior to the wedding for the Bride and bridal party. Pictures may be taken inside the Banquet Room. All

personal belongings must be removed from the Banquet Room no later than 30 minutes after the wedding. The doors will then be locked with no re-admittance.

If guests wish to purchase beverages before or after the ceremony, they may do so through the Tasting Room and enjoy their beverages on the reserved Gazebo and/or Arbor area.

There is limited electricity at the Arbor and the Gazebo. The Arbor is handicap accessible.

Wedding Reception Packages:

Reservation Fees:

Reception for 100 people: \$3,550.00 + tax Reception for 150 people: \$4,050.00 + tax Reception for 200 people: \$4,625.00 + tax

If an arbor ceremony is included there will be a \$1.00 charge per chair for lawn seating.

Rental prices do not include the bar fee, wedding ceremony fee, caterer, linens, flowers, table arrangements, cake, photographer, music, etc.

Payment for the Wedding Reception with tent must be made in full at the time the reservation is made. Wedding Receptions are scheduled for 4 hours.



Price for 150 people includes the following:

- Tent: 40' x 60' white tent with side panels (for inclement weather & perimeter lighting)
- Tables
 - o (19) 60" round tables (each table seats 8 guests)
 - o (2) 60" round tables for wedding items (cake, gifts, guest book, cookies, etc.)
 - o (7) 8' long banquet tables for bridal party, food, and bar
- 150 Chairs
- (1) Elite portable restroom trailer with 4 separate restrooms, running water & AC
- (2) Pavilions for the bar, music, and dance
- (1) Bartender
- A \$30 fee will be added for each additional table of 8.

Wedding Reception Bar Fees:

There are 3 tiers of beverage options offering a variety of Mastropiétro Wines, liquors, beer, soft drinks, and mixers. These prices are per person for a four-hour event and are based on the guaranteed number of quests unless your number is actually greater. Packages include drinks and bartender.

1. FIRST TIER - \$12.00 per person

Wine: Choose four (4) wines from the Mastropiétro Wine List

Beer: Choose two (2) domestic beers**

2. SECOND TIER - \$16.00 per person

Wine: Choose two (2) wines from the Mastropiétro Wine List

Beer: Choose two (2) domestic beers**

Liquor*: J & B Scotch, Beefeaters or Seagram's Gin, Smirnoff Vodka, Jim Beam Bourbon, Peach Schnapps, Amaretto, Bacardi Rum, El Toro Tequila, Canadian Club Whiskey, Seagram's VO Whiskey

3. THIRD TIER - \$20.50 per person

Liguor*: Bacardi Rum, Tangueray Gin, Grey Goose Vodka, Makers Mark, Johnny Walker Red, Peach Schnapps, Amaretto, Cuervo Tequila

Wine: Choose two (2) wines from the Mastropiétro Wine List

Beer: Choose two (2) domestic beers**

Liquor*: Bacardi Rum, Tanqueray Gin, Grey Goose Vodka, Makers Mark, Johnny Walker Red, Peach Schnapps, Amaretto, Cuervo Tequila

**Domestic Beer Selection: Budweiser and Bud Lite, Miller and Miller Lite, Coors Light.

*Mixers Provided: Orange Juice, Cranberry Juice, Grapefruit Juice, Soft Drinks and Water.

Please Note: All bar prices are subject to a 7.5% Sales Tax and a 20% Service Charge. If the event exceeds 4 hours, there will be a \$3.00 per person charge per 1/2 hour on top of the Tier price.

Shots for a money dance are not permitted with any Tier Package. Cost is determined by bottle selection.

The Bar Fee must be paid in full at the end of the event. A credit card must be provided to the Tasting Bar area prior to the event beginning and the Bar Fee charged will depend on the number of people expected or more if addition guests attend.

General Information:

Reservations & Payments:

Payment for a Wedding Ceremony or Reception must be made in full at the time the reservation is made. The Bar Fee must be paid in full at the end of the event.

Cancellation Policy

Cancellations made prior to 60 days before the reserved date will receive an 85% refund. Cancellations made within 45 to 60 days before the reserved date will receive a 50% refund. Cancellations made less than 45 days before the reserved date will not receive a refund. Refunds will be processed and mailed to the Licensee within five (5) business days after the cancellation is received by the Winery.

Weather:

The Winery unfortunately has no control over the weather and has no indoor areas for ceremonies or receptions if the weather is not suitable. The Licensee is responsible for alternative plans.

Clean-Up

General cleanup of the rental area after the event is the responsibility of the Licensee. All trash must be bagged and tied securely. If a bartender is not secured for the event, it is the responsibility of the Licensee to return all wine glasses and /or pitchers to the Tasting Room staff; a busing bin will be provided. Containers can be provided for recycling purposes.

Parking

Parking spaces cannot be reserved for a private party during the normal working hours of operation. Guest parking must be in designated parking areas only and not on the grassy area between the pavilion(s) or Gazebo and the Winery's main building.

Catering

There are five (5) local caterers available for our rentals. You may work with the caterer directly. Rentals may not be self-catered.
